COORDINATION OF SERVICES

Coordination of Services

The Gainesville City School System will integrate Parent and Family Engagement programs in Part A with parent and family engagement strategies under the following programs: Pre-K, Homeless, Neglected and Delinquent, Sp.Ed., Migrant, and other district programs by:

- Offering preschool housed at Centennial Arts Academy and provides preschool for students with special needs

- Partnering with the Boys and Girls Club of Lanier and The Hub located at GHS to
 provide after school care and academic support in addition to community resources to
 support the whole family.
